### **SUMMARY**

Responsible for implementing and evaluating the nutritionist education component of the WIC program by performing the following duties.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

Basic computer knowledge in performing general office work relating to nutrition education.

Develops and implements high-risk care plans and oversee high-risk care to all participants.

Coordinate nutrition education, including breastfeeding promotion and support that is responsive to the identified needs/interests of each high-risk participant.

Referral high- risk participants to other health-related and social service, as necessary.

Track high-risk participants' progress in improving their health and document outcome.

Ensure the efficient flow of the assessment and education process.

Perform anthropometry and hematological testing.

Provide leadership in planning, conducting, and evaluating Participant Centered Nutrition Education services.

Determines community nutrition resources.

Participates in community organizations such as local nutrition education.

Provide leadership in developing, conducting and evaluating nutrition training for local agency staff in nutrition education topics.

Expands and updates referral system.

Participates in State, regional and local programs and conferences to keep abreast of new development in nutrition.

Adhere to all agency safety policies, as well as any State, Federal, or other applicable regulations.

Perform other duties on an as needed basis.

Other duties may be assigned.
